Subject: Transfer of compensation towards cost for Land and Mine Infrastructure in respect of Amelia North coal mine to the Commissioner of Payment for further disbursal to the prior allottees i.e. M/s. Madhya Pradesh State Mining Corporation ltd.

## Sir/Madam,

I am to convey the sanction of the President to the transfer of a sum of Rs. 50,53,76,548/- (Rupees Fifty Crore Fifty three Lakh Seventy Six thousand Five hundred and Forty Eight only) to the Coal Controller's Organisation for disbursement to M/s. Madhya Pradesh State Mining Corporation Itd, the prior allottee of Amelia North coal mine under the provisions of the Coal Mines (Special Provisions) Act, 2015 by the Coal Controller in his capacity as 'Commissioner of Payments' towards compensation for Land and Mine Infrastructure.

2. The amount of compensation for Land and Mine Infrastructure for Amelia North coal mine has been calculated as **Rs.1,11,00,674/-** and **Rs. 49,42,75,874/-** respectively.

- 3. Here, it is pertinent to mention that in accordance with the Coal Mines (Special Provisions) Act, 2015 ("Act") and the Coal Mines (Special Provisions) Rules, 2014 ("Rules"), the Nominated Authority had issued notices dated March 12, 2015, April 22, 2015, September 17, 2015, December 15, 2015 and June 02/03, 2016 inviting claims from Secured Creditors/Government Authorities in respect of Schedule I coal mines.
- 4. In pursuance to the aforesaid notices, ICICI Bank lodged its claim for Rs. 1,35,00,00,000/- against the said coal mine. The claim of ICICI Bank was forwarded to M/s. MPSMCL for confirmation. M/s. MPSMCL vide letter dated 17.08.2016 has stated that it had formed a JV company named Madhya Pradesh Jaypee Minerals Ltd. with 51% shareholding of MPSMCL and 49% of Jaiprakash Associates Ltd. Further, M/s. MPSMCL has stated that ICICI Bank has granted loan to the JV Company. The debt is secured by way of movable/immovable properties (except mining land) of the JV company. Further, JAL has substantial dues payable to MP state government.
- 5. As Mining Lease has been executed in favour of M/s. MPSMCL, M/s. MPSMCL is the prior allottee in terms of the Coal Mines (Special Provisions) Act, 2015. The loan has been granted by ICICI Bank to the JV Company i.e. Madhya Pradesh Jaypee Minerals Ltd. As such, the claim of ICICI Bank is hereby rejected.
- 6. Further, Coal Controller Organisation has lodged its claim for an amount of Rs. 2,78,11,613/- against amount outstanding towards escrow account stating it as security deposit. Since security deposit is not a permissible claim under the Act, the same has been decided as not admissible and has been rejected.
- 7. The aforesaid amount may be transferred through RTGS to the account of Coal Controller, Coal Controller's Organisation who has been appointed as

'Commissioner of Payments' under the provisions of Section 15 (1) of the Coal Mines (Special Provisions) Act, 2015 for the purpose of the said Act vide Ministry of Coal's Order No. 22/2/2014-ASO dated 15<sup>th</sup> July, 2015.

- 8. The expenditure on this account is debitable to the Head **8443.00.117.03.04.00**.
- 9. This issues with the approval of Integrated Finance Division, Ministry of Coal vide Note dated 18.10.2016.
