Sub: Furnishing of Bank Guarantee (BG) in respect of Mahanadi & Machakata coal blocks in the State of Orissa allotted to M/s Maharashtra State Electricity Board and M/s Gujarat State Electricity Board-Regarding.

Sir.

I am directed to refer to this Ministry's allocation letter No.13016/13/2005-CA dated 6<sup>th</sup> February, 2006 (Annexure-I) and to this Ministry's show cause notice letter No. 13011/32/2012-CA-I dated 4<sup>th</sup> May, 2012 (Annexure-II) and to your reply to the show cause notice and the Presentation made/documents submitted by you on 9<sup>th</sup> October, 2012 before the Inter Ministerial Group (IMG) on the above subject.

- 2. Mahanadi and Machhakata coal blocks located in the State of Orissa were allocated jointly to M/s Maharashtra State Electricity Board and M/s Gujarat State Electricity Board in pursuance of the Section 3(3)(a)(i) of the Coal Mines (Nationalisation) Act, 1973 subject to certain terms and conditions. In the allocation letter, at point No.(viii) the following is stipulated as under:-
- "(viii) Violation of any of the conditions imposed above on the part of GSECL and MSEB or such joint venture Government Company in mining and disposing of coal from the Machhakata and Mahanadi coal block will render the mining lease liable for cancellation."
- 3. The progress of allocated coal block has been reviewed by the Ministry through a Review Committee from time to time wherein the allocatee company gives presentation in respect of the development made by them with reference to the milestones prescribed in the allocation letter. During these meeting following was noted:
  - i. In the review meeting held on 25/26.03.2008 it was noted that block boundary of Mahanadi/ Machhakata blocks is to be finalized in consultation with CMPDI.
  - ii. In the Review Meeting held on 15/16.10.2008, noted that block boundary of the block to be finalized in consultation with CMPDI. Exploration in respect of Mahanadi block was to be completed early.

Short

- iii. Further, the Review Committee in its meeting held in 22/23.06.2009 noted that all the milestones were pending except purchase of GR, submission of ML, application and Mining Plan.
- iv. In the Review Committee meeting held in on 20/21.07.2010 it was noticed that FC, EMP, ML & LA were pending. MP was approved. Forest application was to be submitted. MOC advised to expedite progress.
- v. The Review Committee meeting held on 11/12.01.2012 noted that FC(Stage-I), EMP, ML & LA are pending. Previous approval obtained recently. PH for EMP is not yet completed. Villagers resistance and land acquisition is the main issue. The company was issued the show cause notice. The company furnished their reply to the show cause notice.
- 4. In the meantime, the Government has set up an Inter-Ministerial Group (IMG) under the Chairpersonship of Additional Secretary (Coal), Ministry of Coal having members from Ministry of Power, Ministry of Steel, Ministry of Commerce & Industry, Department of IPP, Ministry of Law and Justice, Department of Legal Affairs, Department of Economic Affairs. The IMG has been given the mandate to review the progress of development of allocated coal blocks and associated end use projects and to recommend action including de-allocation, if required.
- 5. The case of the allocate company was referred to IMG. Accordingly, the IMG asked the allocatee company to make the presentation before it on the progress of development of allocated coal blocks and associated end use project. The representatives of the allocatee company gave presentation on 9<sup>th</sup> October, 2012 before the IMG. The IMG considered the presentation, the status note of the Mahanadi & Machakata coal blocks and associated EUP prepared by Ministry of Coal and Coal Controller's Organisation (Annexure-III). The progress of development of the block with reference to the milestones and their achievement is as under:-

6. After detailed deliberations, the IMG made the following recommendations:-

#### GUJARAT STATE ELECTRICITY CORPN. LTD. & MESB (MAHANADI MACHHAKATA)

The IMG considered the terms and conditions of allocation, the show cause notice issued, the reply and the presentation made by the company along with the status paper placed before the IMG. The IMG noted that 6 years 9 months have elapsed from the date of allotment i.e. 6.2.2006. IMG also noted that the company has purchased the GR and the mining plan is approved, EC and FC clearances are pending. No land has been acquired as yet however, notification w/s 4 was reported issued for 80% of the land and w/s 6 of Land Acquisition Act for 20% of the land. Rs. 28 crore has been deposited for land in 2009. JV has been constituted on 1.11.2006. MDO has been appointed on 25.2.2009. Investment made in the coal block as per CA certificate submitted by the JV is Rs. 50.70 crore. The allocatee companies GSECL and MAHAGENCO(earlier MSEB) are also setting up their end-use power plants. As per CA certificate, Rs. 8205.06 crore investment has been reported on the end-use power plants of MAHAGENCO and Rs. 2574.30 crore by GSECL. During presentation, the company argued that the entire delay was not attributable to them. They assured that they will be in a position to open the mine by April, 2014 whereas the normative date for start of production was 6.8.2009.



IMG noted that this is a regionally explored block and the allocatee has now completed exploration and is in a position to take further steps for the development of block. IMG noted that as per terms and conditions of allocation any slippage pertaining to the period of 27 months allowed for exploration would render the allocation liable for cancellation and withdrawal of block from the allocatee.

However, taking into account all factors, the IMG did not consider it appropriate to recommend de-allocation of the coal block at this stage and recommended that the allocatee may be permitted to continue holding the block only on submission of BG equivalent to one year royalty for adherence to milestones. IMG further recommends that the BG may be submitted within a period of three months from the date of issue of letter in this regard failing which the block may be de-allocated.

- 7. The recommendation of the IMG has since been considered and accepted by the Government.
- Accordingly, M/s Maharashtra State Electricity Board and M/s Gujarat State Electricity Board are directed to furnish a Bank Guarantee (BG) for an amount of Rs. 268.80 Crore (Rupees two hundred sixty eight crores and eighty lakhs only) to the Coal Controller's Organisation within a period of three months from the date of issue of this letter in this regard failing which the block may be de-allocated. The calculation of amount for the purpose of furnishing Bank Guarantee as provided by the Coal Controller is at Annexure –IV.

Sir.

I am directed to refer to your letter No. nil dated 2<sup>nd</sup> February, 2005 on the above subject and to convey the 'inprinciple' consent of the Government of India to the working of Machhakata and Mahanadi coal blocks jointly by the GSECL and MSEB within the provision of Government Company dispensation under Section 3(3))a)(i) of the Coal Mines (Nationalisation) Act. 1973 subject to the following conditions:-

- i) The blocks shall be worked as one mine for M/s GSECL and M/s MSEB.
- ii) Coal mining shall be carried out by a joint venture company with GSECL and MSEB participation provided such separate company is a Government company with coal mining as object in its Memorandum of Association as provided under Section 3(3) (a)(i) of the Coal Mines (Nationalisation) Act, 1973 which allows mining by a Government Company.
- iii) The coal produced from the block shall be shared between GSECL and MSEB in ratio of 40% and 60% respectively.
- iv) Coal Linkages from CIL/SCCL would not be disturbed in any way with coal mined from Mahanadi and Machhakata coal blocks. In case there already exist linkages from the above sources. GSECL and MSEB shall continue to honour their commitment towards long-term linkage from these nationalized coal companies to their thermal power stations through FSAs.

- v) The Company will do coal mining in accordance with the provisions of the Coal Mines(Nationalisation) Act, 1973, the Mines and Minerals (Development & Regulation) Act, 1957, the Contract Labour (Regulation & Abolition) Act, 1970, and all the minerals, environmental and labour laws and other regulations governing coal industry.
- vi) The joint venture company would plan for both open cast and underground mining in Machhakata and Mahanadi coal blocks so as to extract the reserves to the maximum extent possible.
- vii) The mining lease will be executed in the name of the joint venture company which shall be formed with equity participation from GSECL and MSEB within a period of 45 days from the date of this letter.
- viii) Violation of any of the conditions imposed above on the part of GSECL and MSEB or such joint venture Government Company in mining and disposing of coal from the Machhakata and Mahanadi coal block will render the mining lease liable for cancellation.
- ix) CMPDIL has undertaken the detailed exploration of the Mananadi and Machhakata blocks. GSECL and MSEB, jointly or through the joint venture, shall obtain the geological report of the block from CMPDIL on payment of necessary exploration cost on completion of the exploration.

Sir.

I am directed to refer to this Ministry's letter No.13016/13/2005-CA-I dated 06.-2.2005 conveying allocation of Mahanadi & Machakata coal block in pursuance of the provisions contained in Section 3(3)(a) of the Coal Mines (Nationalization) Act, 1973, subject to certain conditions. One of the conditions of allocation was that coal production from the captive block shall commence within 36 months (42 months in case the area is in forest land) in case of open cast mine and in 48 months (54 months in case the area falls under forest land) in case of UG mine from the date of allocation letter. The end- use project schedule and the coal mine development schedule should be modified accordingly and submitted to the Ministry within 3 months from the date of allocation.

2. In order to expedite the development of the coal block, various review meetings were held from time to time with the representatives of the company. In

S

the review meeting held on 11/12.01.2012, it was noticed that no serious efforts have been made by the company to develop the coal block, even after repeated assurances tendered by the Company during the period. It is also noted that all the important/critical milestones such as grant of previous approval, EMP, Forest Clearance, Mining Lease and land acquisition are pending for Mahanadi and Machakata coal block. The company has repeatedly failed to keep its promises made to the Ministry and is thus non-serious about timely development of the block. The details of milestones to be achieved and the time lapsed against each milestone are given in the table below:-
