MINUTES OF THE MEETING TO REVIEW OF THE PRODUCTION STATUS OF COAL MINES ALLOCATED UNDER THE PROVISIONS OF THE COAL MINES (SPECIAL PROVISIONS) ACT, 2015 HELD AT 11.45 AM IN CIL OFFICE, CORE-6, 6TH FLOOR, SCOPE COMPLEX, LODHI ROAD, NEW DELHI-110001.

- 2. JS (AU) welcomed all the officers/ allocates of producing coal mines present in the meeting and stressed upon the rising demand of coal and the need to meet the same by producing more coal from the coal mines. JS (AU) also expressed his concern that some allocatees of coal mines are not producing that much coal in FY 2019-20 which they were producing in the corresponding period in FY 2018-19 and advised the allocatees to resort to every possible effort to enhance production and reach mine PRC expeditiously.
- 3. Thereafter, JS (AU) enquired the production status of coal mines from the representatives of allocatee companies one by one and the issues faced by them in non-achievement of desired coal production as approved in the mining plan. The production status of the coal mines is as under:-
