Subject:— Recored Note of Discussions in the Meeting on Coal Block Allocation to Government Companies/Corporations and CPSUs (joint allocation) under Rule 4 of the Auction by Competitive Bidding of Coal Mines Rules, 2012, — reg.

Record Note of Discussions in the Meeting on Coal Allocation to Government Companies/Corporations and CPSU's under Rule 4 of the 'Auction by Competitive Bidding of Coal Mines Rules, 2012' held under the Chairmanship of Additional Secretary (Coal) on 29th August, 13 at 11.00 AM in New Delhi.

List of Participants is enclosed at Annexure.

- Welcoming the participants, Additional Secretary, Ministry of Coal 2. mentioned that the allocation of 14 coal blocks to different government companies/CPSUs was placed on the website of Ministry of Coal on 3-7-2013. The letters of allocation of coal blocks to the State Government Companies/Corporations/CPSUs have been issued in those cases where independent allocation was approved. However, wherever the size of block was large and joint allocation of coal blocks was decided, which involved two or more government companies/corporations/CPSUs, the letters of allocation could not be issued in view of the need for indicating/forming of SPV/JV company by these government companies/corporations/CPSUs with which MoC would enter into agreement as per the laid down procedures under the Rules for 'Auction by Competitive Bidding of Coal Mines Rules, 2012' (hereinafter referred to as Rules). The purpose of this meeting is to impress upon the allocatee Govt. companies/corporations/CPSUs that for operational purposes, the joint allocatee States/companies/corporations/CPSUs should form SPV/JV or any other form of body incorporated as an independent entity in which all the end users to whom coal reserves have been allocated are represented in a fair and transparent manner.
- 3. Representatives of state Governments/government companies/CPSUs were requested to offer their views on the subject so that steps for formation of SPV/JV were expedited by the allocatees to enable the Ministry of coal to take forward the process of entering into an agreement under the Rules.
- 4. In regard to Kudanali-Luburi coal block in Odisha, which has been jointly allocated to NTPC and J&K State Power Dev. Corp. Ltd., the representative of J&K mentioned that, the state had already initiated discussions/consultation with NTPC and would revert with firm proposal for formation of SPV/JV

agreement by 30th September, 2013. The representatives of both NTPC and J&K SPDCL requested for one more month time i.e. by 31st October, 2013 for finalization of above agreement as per rules.

- 5. Regarding Jilga-Barapalli (Host State: Chhattisgarh), the representatives of NLC and CSPGCL agreed to initiate the discussions at the earliest and meet the same time-lines of 30th September, 2013 to finalize the structure of the proposed SPV/JV and 31st October, 2013 for signing the agreement as per the rules.
- 6. With respect to Mahajanwadi (Host State: Maharashtra), only the representative of GSECL was present and shared the states' earlier experience with Maharashtra government's company i.e. MAHAGENCO. He also agreed to initiate discussions with the concerned representatives of MAHAGENCO and assured to adhere to the mutually agreed time-lines of 30th September, 2013 to finalize the SPV/JV and 31st October, 2013 for signing the agreement as per the rules.
- 7. As far as Kalyanpur-Badalpara block, which is located in the State of Jharkhand, the representatives of both UPRVUNL and HPGCL agreed to initiate the discussions and would adhere to the agreed time-lines of 30th September, 2013 to finalize the structure of the proposed SPV/JV and 31st October, 2013 for signing the agreement as per the rules.
- 8. Deocha-pachami coal block in West Bengal is the largest block. It has been jointly allocated to six states namely West Bengal, Karnataka, Bihar, Punjab, Tamil Nadu and Uttar Pradesh, the representatives of these States/companies/ corporations agreed with the general approach of formation of SPVs/JVs and requested one extra month's time in view of more number of coal block allocatees. In this case it was agreed that the above mentioned exercise of finalizing the proposed structure of SPV/JV by 31st October, 2013 and for signing the agreement by 30th November, 2013, as per the rules.

- 9. The representatives of the State govt. companies requested the Ministry of Coal to issue the allocation letters specifying the names of the joint allocatees and the reserves allocated to individual Govt. companies/corporations/CPSUs. It was decided that Ministry of Coal would address the Chief Secretary of concerned states (allocatees) with copies to the allocatees.
- 10. It was also decided that the draft agreement proposed to be signed under the 'Auction by Competitive Bidding of Coal Mines Rules, 2012' would be circulated to all the allocatee companies/corporations/CPSUs for initiating and completing the exercise within the time-lines mentioned above.
- 11. Some of the State Govt. representatives requested for basic geological information/data about the above coal blocks. In response, it was mentioned that these details of all the coal blocks that had been allocated, were already available on the web-site of Ministry of Coal which were placed at the time of NIA dated 31.12.2012.
- 12. Some of the representatives of Govt. companies/corporations raised certain issues in regard to operational aspects of development of coal blocks. It was clarified that allocatees should mutually sort out all such operational issues at their level.

The meeting ended with vote of thanks to the chair.
