OFFICE MEMORANDUM

Subject: Constitution of Technical Committee to formulate criteria and classify coal blocks for auction and allotment - reg.

In continuation of this Ministry's OM Nos.13016/9/2014-CA-III dated 29.10.2014 and 15.07.2015 (copies enclosed) regarding constitution of Technical Committee (TC) to formulate and classify coal mines for auction and allotment, with the approval of the competent authority, the TC constituted is hereby empowered to also classify coal blocks for auction and allotment of coal blocks identified for allocation under the provisions of Mines & Minerals (Development & Regulation) Act, 1957. The composition of the TC shall remain unaltered.

2. Accordingly, Terms of Reference (ToR) of the Technical Committee constituted shall further include the following, in addition to the existing ToR:-

- I. To classify coal blocks for the purpose of specified end uses for allocation under the provisions of the Mines & Minerals (Development & Regulation) Act, 1957 (MMDR Act).
- II. To prepare pre-determined evaluation criteria for allocation of coal mines blocks as identified for allocation under the provisions of MMDR Act.
- III. Any other issue as may be referred to the TC by the Government and also as may be deemed appropriate by the TC.

- V. Any other issues as may deemed necessary by the Committee.
