Constitution of Inter-Ministerial Committee for proposed auction of coal linkages/LoAs through competitive bidding. - reg.

The Government is contemplating to introduce auctioning of coal linkages/LoAs through competitive bidding as the selection process. To consider various models and to recommend the optimal structure that would meet the requirements of all the stakeholders, it has been decided to constitute an Inter-Ministerial Committee (IMC) under the Chairmanship of Additional Secretary, Ministry of Coal, with the following representatives (not below the rank of Joint Secretary).
