Subject: Deduction of Bank Guarantee(BG) in respect of Kosar Dongargaon Coal block allocated to M/s Chaman Metallics Ltd. - regarding.

Sir,

I am directed to refer to this Ministry's letter No. 38011/11/2006-CA-I(Part) dated 20.02.2007 conveying allocation of **Kosar Dongargaon** coal block in pursuance of the provisions contained in Section 3(3)(a)(iii) of the Coal Mines (Nationalisation) Act, 1973, subject to certain conditions (**Annexure-I**). One of the conditions of allocation was that the coal production from the captive block shall commence within 36 months (42 months in case the area is in forest land) in case of open cast mine and in 48 months (54 months in case the area falls under forest land) in case of UG mine from the date of preparation of GR. The end use project schedule and the coal mine development schedule were to be modified accordingly and submitted to the Ministry within 6 months from the date of allocation.

- 2. One of the other important conditions was that the allocation/mining lease of the coal block may be cancelled, inter-alia, on the following grounds:-
- a. Unsatisfactory progress of implementation of their end use sponge iron plant/power plant.
- b. Unsatisfactory progress in the development of coal mining project.
- c. For breach of any of the conditions of allocation.

The de-allocation/cancellation of mining lease shall be without any liability to the Government or its agencies, whatsoever. Any expenses incurred by the allocatee or any right or liability arising on the allocatee out of the measures taken by him shall solely be to his account and in no way be transferred to or borne by the Government or its agencies.

3. In order to expedite the development of the coal blocks, review meetings were held from time to time. In the review meeting held on 15/16.10.2008, it was noticed that all the milestones pending except GR purchased, BG and MP submitted. In the review meeting held on 22/23.06.2009 it was noticed that GR purchased, BG and MP submitted, applied for ML No FC is required as entire land is on private land. All other milestones were pending and there was no progress since last review meeting. In the

review meeting held on 20/21.07.2010 it was noticed that EMP, ML & LA were pending. Review committee noticed slow progress & behind schedule.

- 4. In the review meeting held on 11/12.01.2012, it was noticed that the progress of the Kosar Dongargaon coal block allocated to the company is not satisfactory. The Committee expressed concern over unsatisfactory progress and advised to expedite the development of the coal block. Accordingly, a caution letter dated 26.04.2012 was issued to the company with the direction to expedite the development of the coal block and be careful in future with respect to the milestones stipulated.
- 5. In the meantime, the Government has constituted an Inter-Ministerial Group (IMG) on 21.06.2012 under the Chairmanship of Additional Secretary, Ministry of Coal having members from Ministry/Department of Power, Steel, Industrial Policy & Promotion, Legal Affairs and Economic Affairs. IMG has been given the mandate to review the progress of development of allocated coal blocks and associated end use projects and to recommend action including de-allocation, if required. IMG in its 18th meeting held on 01.05.2013 inter alia considered the status of the development of the Kosar Dongargaon Coal Block prepared by the Coal Controller's Organisation (CCO) as on 31st December, 2012 and noted that no significant progress was made by the company towards development of the coal block. It was noticed that a number of important/critical milestones were pending. Keeping in view the unsatisfactory progress, IMG recommended to issue show cause notice for delay in development of coal block. Accordingly a show cause notice dated 06.06.2013 was issued (Annexure-II).
- 6. Subsequently, on receipt of reply in response to show cause notice, the IMG asked the allocatee company to make a presentation before it on the progress of development of allocated coal block and associated end use project(s). The representatives of the company gave presentation on 25.10.2013 before the IMG in its 23<sup>rd</sup> meeting. The IMG considered the presentation, the status of the Kosar Dongargaon coal block and associated end use project(s) prepared by the Ministry of Coal and Coal Controller's Organisation (Annexure-III). The details of milestones to be achieved and the time lapsed against each milestone, as reported by the Office of Coal Controller, are given in the table below:

7. After detailed deliberations, the IMG made recommendation for deduction and encashment of proportionate BG linked to the milestones set for development of the block as per the allocation letter of **Kosar Dongargaon** coal block. The recommendations made by the IMG are as follows:-

"Kosar Dongargaon coal block was allocated to M/s Chaman Metalics Ltd. on 20.02.2007. The normative date of production as per Coal Controller's Organisation (CCO) report was 20.02.2011. The progress of block development was reviewed by the IMG in its 18<sup>th</sup> meeting held on 01.05.2013 and as per the recommendations of the IMG, the allocatee company was issued a show cause notice (SCN) vide MoC's letter dated 06.06.2013. The reply of the allocatee company to the SCN dated 26.06.2013 was sent to the State Govt. for comments. However, the comments of the State Govt. were not received.

The IMG considered the terms and conditions of allocation, the show cause notice issued, reply of the block allocatee to the show cause notice issued, status report of CCO, presentation made by the allocatee company on 25.10.2013 along with the status paper presented to the IMG.

IMG noted that as per CCO's status report, all milestones are achieved except execution of mining lease; however, there have been delays in achieving milestone. There is no forest land involved and land will be purchased by direct purchase. Execution of Mining Lease, ming opening permission and coal production are pending.

The IMG considered the reply of the allocattee to the show cause notice wherein the allocatee has mainly stated that all the major/critical milestones have been achieved except execution of



mining lease with the State Govt. of Maharashtra, land acquisition and application for opening permission of coal mine. Company has stated that pending milestones could only be initiated once the mining lease is executed. As regards EUP, the same is commissioned. IMG noted that there is no forest land involved and therefore, forest clearance is not required. This being the underground mine, large extant of land is not required. An extent of 40 hectare of land is required, which the party is going to acquire by direct purchase. Prior approval of the Central Govt. for grant of mining lease has already been given.

As per CA certificate submitted by the company, investment in coal block and EUP is Rs. 1.62 crs. and Rs.42.09 crs., respectively.

**Recommendation:** Taking into account the facts placed before it including the fact that all requisite clearances have been obtained except execution of the mining lease by the State Government and keeping in view delay in achievement of milestones, IMG recommends deduction and encashment of proportionate BG linked to the milestones set for development of the block as per the allocation letter."

8. The recommendation of the IMG has since been considered and approved by the Government. As the allocatee company has been given a number of opportunities to develop the coal block and the associated end use project and the company has failed to develop the same as per the milestones prescribed without any valid reasons for the delay, it has been decided to deduct and encash proportionate Bank Guarantee (BG) of Rs.0.14025 crore (Rupees fourteen lakhs two thousand five hundred only) linked to the milestones set for development of the block as per the calculation sheet of BG amount furnished by the Coal Controller's Organisation, Kolkata (Annexure-IV). As per order dated 03.12.2013 of Hon'ble High Court of Judicature at Bombay, Nagpur Bench, Nagpur in W.P. No. 6400/2013, this order shall come into effect after seven (07) days from the date of dispatch.

Subject: Allocation of Kosar Dongergaon coal block in the State of Maharashtra for captive mining of coal by M/s. Chaman Metaliks Ltd. for their 0.363 mtpa sponge iron plant in Chandrapur, Maharashtra.

Sir.

I am directed to refer to the request of M/s. Chaman Metaliks Ltd., for allocation of coal block in the State of Maharashtra and to state that the request of the company has been considered by the Central Government and it has been decided to allot Kosar Dongergaon coal block in WCL command area to M/s. Chaman Metaliks Ltd., to meet the coal requirements for their 0.363 mtpa sponge iron plant in Chandrapur, Maharashtra. This allocation is in pursuance of the provisions contained in Section 3(3)(a)(iii) of the Coal Mines (Nationalization) Act, 1973 and subject to the following conditions:-

- i) The allocation of the Kosar Dongergaon coal block to M/s Chaman Metaliks Ltd. has been made to meet the coal requirement of their 0.363 mtpa sponge iron plant in Chandrapur, Maharashtra.
- ii) The block is meant for captive use in their own specified end use project i.e. sponge iron production. The coal produced from the block shall not replace any coal linkages given to M/s. Chaman Metaliks Ltd. by the Coal India Ltd./ its subsidiary and/or by the Singareni Collieries Company Ltd., without prior permission of this Ministry.
- iii) Middlings generated in the process of washing the coal shall be used for power generation in their own power plant i.e., the useable middlings/rejects generated during beneficiation shall be used captively by the allocatee. The modalities of disposal of surplus coal/middlings/rejects, if any, would be as per the prevailing policy/instruction of the government at the relevant point in time and could also include handing over such surplus coal/middling/rejects to the local CIL subsidiary or to any person designated by it at a transfer price to be determined by the Government.
- iv) Coal production from the captive block shall commence within 36 months (42 months in case the area is in forest land) in case of open cast mine and in 48 months (54 months in case the area falls under forest land) from the date of this

letter in case of UG mine. The end-use project schedule and the coal mine development schedule should be modified accordingly and submitted to the Ministry within 3 months from the date of this letter. A copy of the indicative milestone chart is enclosed.

- v) The company shall buy geological report from CMPDIL / Directorate of Geology & Mining, Govt. of Maharashtra within six weeks from the date of this letter.
- vi) The company shall submit a bank guarantee for Rs. 2.55 crores (equal to one year's royalty amount based on mine capacity of 0.3 mtpa assessed by CMPDIL, grade of coal of E grade and the weighted average royalty @ Rs. 85 per tonne) within three months from the date of this letter. Subsequently upon approval of mining plan the Bank Guarantee amount will be modified based on the final peak/ rated capacity of the mine.
- vii) The company shall submit a mining plan for approval by the competent authority under the Central Government within six months from the date of this letter.
- viii) The progress of the mine will be monitored annually with respect to the approved mining plan, which will mention the zero date. In case of any lag in the production of coal, a percentage of the bank guarantee amount will be deducted for the year. This percentage will be equal to the percentage of deficit in production for the year with respect to the rated/peak capacity of the mine, e.g., if rated/peak capacity is 100, production as per the approved mining plan for the relevant year is 50 and actual production is 35, then (50-35)/100x100 = 15% will lead to deduction of 15% of the original bank guarantee amount for that year. Upon exhaustion of the Bank Guarantee amount the block shall be liable for de-allocation/cancellation of mining lease. M/s. Chaman Metaliks Ltd. shall ensure that the Bank Guarantee remains valid at all times till the mine reaches its rated capacity or till the Bank Guarantee is exhausted.
- ix) No coal shall be sold, delivered, transferred or disposed of except for the stated captive mining purposes, and except with the previous approval of the Central Government.
- x) Mining of coal from the allocated captive coal block shall be carried out in accordance with the applicable Statutes/Rules/Orders/Directions governing the mining of coal in the country.
- xi) Those of the above conditions relevant at the time of grant of mining lease shall be included as additional conditions in the mining lease in addition to any further conditions imposed by or agreed to by the Central Government.
- xii) The State Government at the time of seeking previous approval for the grant of mining lease shall submit a draft of the mining lease containing the above relevant conditions for vetting by the Central Government. The final mining lease shall be as vetted/modified by the Central Government Any deviation from the vetted/modified draft shall render the mining lease deed *ab-initio* null and void and without effect
- 2. Allocation / mining lease of the coal block may be cancelled, inter-alia, on the following grounds:-

- Unsatisfactory progress of implementation of their end use sponge iron plant / power plant.
- Unsatisfactory progress in the development of coal mining project.
- For breach of any of the conditions of allocation mentioned above.

The De-allocation/cancellation of mining lease shall be without any liability to the Government or its agencies, whatsoever. Any expenses incurred by the allocatee or any right or liability arising on the allocatee out of the measures taken by him shall solely be to his account and in no way be transferred to or borne by the Government or its agencies.

3. The company may approach CMPDIL / Directorate of Geology & Mining, Govt. of Maharashtra for the geological report and contact the State Government authorities concerned for the necessary permissions/clearances etc. for attaining mining rights and related matters. The arrangement of transport of coal will have to be worked out by the company in consultation with the Ministry of Railways / Ministry of Surface Transport depending on the mode of transport.
