The recommendation of the SLC (LT) is as under:-

Supply of Coal beyond 31.03.2015 to EUPs affected by de-allocation of coal blocks and environmental clearance issues, covered under decision of Special meeting of SLC (LT) held on 03.12.2014.	The Committee recommended that the supply of coal to EUPs covered in category 9 (a) who had normal linkages before allocation of earlier coal blocks, should continue till 30.06.2015 since these are running plants. However, in case supply of coal starts from Schedule – II blocks allocated to fresh allocatees in the current auction process, this dispensation shall cease in respect of the units linked to such coal blocks.

The above recommendation of the SLC (LT) has been approved by the competent authority.
