- The Terms of Reference (ToR) of the Committee are as under-
- (A) To specify the manner of allocation of a coal/lignite block through (i) auction; or (ii) allotment to Government Company or corporation under clause (a) allotment to Government Company or corporation under clause (a) of the proviso to section 11A of the MMDR Act; or (iii) allotment to a company or corporation under clause (b) of the proviso to section 11A of the MMDR Act.
- (B) To decide future course of allocations in respect of coal/lignite blocks which were earlier allocated under the MMDR Act, 1957 but CBDPA/Allotment Agreements terminated later on.
- (C) To decide coal blocks, from the identified coal blocks, which may be earmarked for Sale of Coal.

3. The committee will submit its recommendations to the Government for approval.
