Subject: Notification of Representative Prices for March 2020

For auction of coal mines for Commercial Mining based on Revenue Sharing, the concept of Representative Prices for each Grade of Coal has been conceptualised. The technical formulation of the concept was developed by Indian Statistical Institute, Kolkata. All the Revenue Share of the auctioned mines would be computed on the basis of the Representative Prices.

- 2. Representative Price (RP) is the weighted average of the prices of coal from all the Sales Channels viz. the Notified Prices of Coal India (Except WCL), WCL and SCCL, the Auction Prices of Coal India including Linkage Auction and Import Prices of Coal. The Representative Prices are compiled on the basis of the prices which were prevalent on the particular month.
- 3. The weights for averaging the prices from each sales channels may be summarised as follows:-
