FINANCIAL OUTLAYS AND OUTCOMES

The budget provision and expenditure during the last two years are as under:

During the financial year 2019-20, `823.01 crores was utilized against the allocation of `933.60 crores at RE. The un-utilized amount in financial year 2019-20 mainly due to mandatory provisions for the North-East Region under Central Sector Schemes.

The utilization of funds during the financial year 2020-21 was `433.19 crores (upto December, 2020) against the reduced allocation of `627.58 crores at RE stage.

For FY 2021-22, the allocation has been kept at `534.88 crores. Out of which, `419.98 crores is allocated for


Central Sector Schemes and the remaining amount of `114.90 crores is allocated for Secretariat, Nominated Authority, Coal Controller's Organization and Coal Mines Provident Fund Organization.

The Capital Expenditure (CAPEX) component of Coal PSUs for FY 2021-22 is `19246 crores, to be provisioned from Internal and Extra Budgetary Resources (IEBR). A detailed profile of PSU wise budget allocation and expenditure is given below:
