Utkal A Coal Mine situated in Angul District of Odisha State has been Allotted on November 18, 2021 to M/s Mahanadi Coalfields Limited and Allotment Agreement dated June 15, 2021 signed between the Nominated Authority and M/s Mahanadi Coalfields Limited with respect Utkal A coal mine, under Coal Mine (Special Provisions) (CMSP) Act 2015 and rule made hereunder.

- 2. The undersigned is directed on the subject matter cited above and to request you to furnish the details of amount incurred by Prior Allotee M/s MJSJ Coal Limited a JV company comprising of M/s Mahanadi Coalfields Ltd.
