FINAL ORDER

Subject: - The Coal Mines (Special Provisions) Act, 2015 and Hon'ble High Court of Delhi, Judgment dated March 09, 2017— Valuation of Compensation for payment to prior allottee, M/s Essar Power Limited (EPL) for Chakla coal mine.

In pursuance of Order dated December 16, 2021 tentatively determining the disbursal of compensation to prior allottee of Chakla coal mine, both prior allottee, (M/s EPL) and present allottee, M/s Hindalco Industries Limited (HIL) were called upon January 03, 2022 at 3:00 P.M to present their comments/objections, if any, on the determination of compensation for land and mine infrastructure.

- 2. Accordingly, both prior allottee, M/s EPL and present allocattee, M/s HIL attended the meeting on January 03, 2022 at 3:00 P.M and placed their submissions regarding land documents only. In this regard, M/s HIL stated that M/s EPL has not shared the CA land documents of Chakla coal mine.
- 3. Further, copy of letter No.HIL/CH/FC/2021-22/114 dated 01.02.2022 has been received from M/s HIL communicating to M/s EPL that they have received 10 files containing photocopies (not original) of documents related to 11 villages physically from Mr.Chandan Kumar, Assistant Manager, Corporate Affairs, Essar Power Limited, Ranchi on January 19, 2022. It is observed from the above-mentioned letter of HIL that both parties are coordinating with each other to resolve the issue of mutation of Compensatory Afforestation.
- 4. In view of the above, Order dated December 16, 2021 determining the compensation for cost of GR, cost of consent, mine infrastructure and Compensation for land for Chakla coal mine stands final which is reiterated below:-

- In accordance with Section 27 of the Act, it is open to M/s Essar Power Limited (EPL) and M/s Hindalco Industries Limited (HIL) to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.
