**Subject:-** Inviting bids for supply of Newspapers/Magazines/Journals/ Central Government Rule books in the offices of Ministry of Coal and residence of Minister of Coal-reg.

I am directed to say that bids are invited from the reputed firms/company/individual for supply of Newspapers/Magazines/Journals to various offices of Ministry of Coal located in Shastri Bhawan, Rajendra Prasad Road, New Delhi- 110001 & Lok Nayak Bhawan, New Delhi-110003 and residence of Hon'ble Ministers.

- 2. Interested parties may please send their bids off-line via two-bid-system: (a) Technical Bid, and (b) Financial Bid. The last date of submission of bid is 11.04.2022 on 2:00 PM. The sealed bids may be dropped in the Tender Box mounted on the wall at Garage no.21, Shastri Bhawan, New Delhi. Bids received after stipulated date and time shall not be entertained at all. The Technical Bids will be opened at 3:00 PM on 12.04.2022 at Room No. 104 "C" Wing, Ministry of Coal, Shastri Bhawan, New Delhi-110 001. Financial Bids of technically qualified, eligible bidders fulfilling all the requisite criteria only shall be opened on a date & place to be notified later in presence of short listed contractors or their authorized representatives.
- 3. Incomplete or conditional tenders will not be entertained. The tender of those firms will be entertained who deposit the earnest money amounting to Rs. 10,000/- (Rupees Ten Thousand only) in the form of Demand Draft in favour of "Pay & Account Officer, Ministry of Coal" payable at New Delhi along with the Technical Bid. The Technical Bid received without the EMD will be summarily rejected. The approximate value of annual procurement is Rs. 6 to 7 Lakhs. The successful tenderer/suppliers will be required to submit a Performance Bank Guarantee (PBG) of Rs. 10,000/- (Ten Thousand Only). Bank guarantee shall be valid up to two months beyond the date of completion of all the contractual obligations of the supplier. If successful Tenderer(s) fails to furnish the required bank guarantee within the specified period, EMD will be forfeited and the bidder will be barred from participating in future tender process of the Ministry.
- 4. Technical Bid should include photocopies of the following supporting documents, failing which their bids shall be summarily rejected and will not be considered any further:
  - a. Registered office or one of the Branch offices of the Company/Firm/Agency should be located in New Delhi;
  - b. The Company/Firm/Agency should have at least 03 (three) years of experience of supplying of items in this field in Ministry/Departments/Organizations of the Government of India/ State Government/ PSUs/ Nationalized Banks etc. Documentary evidence of at least one year's experience to be enclosed with the technical bid;
  - c. The bidder should possess valid GST number, attested copies of the which must be submitted with the technical bid;
  - d. Copy of PAN Card:
  - e. The Company/Firm/Agency should submit the Technical Bid in prescribed proforma as per Annexure "A" in compliance with the above requirements.
  - f. Having minimum turnover of Rs. 5 Lakh per year during each of the last three years (documentary evidence to be attached);



- g. Copies of IT returns;
- h. Copy of Affidavit stating that the Company/Firm/Agency is/has not been blacklisted by Central/State Govt./PSU;
- i. The details of the major similar contracts handled by the tendering company/firm/agency on behalf of PSU and Govt. Deptt. during the last three years (Copy to be attached).

#### 2. Financial Bid:-

The financial Bid should contain the rate against each publication and percentage of discount offered, as per Annexure-B and the Bidders have to submit the Financial Bid as per attached Performa, failing which the tender would be summarily rejected.

## Terms and Conditions of Contract for supplier.

- i. Pan Card is mandatory.
- ii. The supply Orders will be placed as and when required, the successful supplier will have to meet all the requirements of the Ministry immediately on the receipt of the supply order either telephonically or on written request.
- iii. It may be noted that the quantity of Hindi/English/requested Regional language Newspapers and magazines may be increased/decreased as per requirement.
- iv. Supplier should provide digital access of newspapers and magazines as required.
- v. Printed Price or combo price as applicable and appearing on Newspaper should be used for calculation of discount and payment.
- vi. Two copies of each bill duly pre-receipted, signed on revenue stamp and certified by the offices/officers to whom newspapers/magazines are supplied must be submitted on **monthly basis** at the earliest.

- vii. The delivery of the Newspapers will have to be made to the various offices of Ministry of coal located in Shastri Bhwan, Lok Nayak Bhawan and residence of Minister of Coal before 9:00 AM.
- viii. The Contract shall remain in force for a period of one year from the date of implementation and can be extended further on the same rate, terms and conditions, or with some addition/deletion/modification, subject to satisfactory service.
- ix. The contract shall automatically expire after one year from commencement of the contract unless extended further by the mutual consent of contracting company (hereinafter referred to as the company) and this Ministry.
- x. The company shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other Company without the prior written consent of this Ministry.
- xi. The tenderer will be bound by the details furnished by it to this Ministry, while submitting the tender or at any subsequent stage. In case, any of such documents furnished by it is found to be false at any stage, it would be deemed to be a breach of the terms of contract making it liable for legal action besides termination of contract.
- xii. Financial Bids for only those tenderers who are declared qualified technically shall be evaluated.
- xiii. The Ministry of Coal reserves its right to terminate the contract at any time without assigning any reasons. The Contractor will not be entitled to claim any compensation against such termination.
- xiv. The EMD in respect of the company which does not qualify the Technical Bid (First Stage)/ Financial Bid (second Competitive Stage) shall be returned to it without any interest.
- xv. The Ministry of Coal reserves the right to withdraw/relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
- xvi. If you are interested to supply Newspapers/Magazines and Indian journals in Ministry of Coal as per terms and conditions cited above, you are requested to quote your % discount that may be offered at printed rates.
- xvii. If two or more companies offer identical discount, the company with higher credential service/experience would be given priority.
- xviii. In case of not adhering to the terms and conditions, 10% of the value of the Newspapers or the bills may be deducted as penalty.

#### Governing Laws and Disputes:-

This shall be construed and governed by the Laws of India and the parties hereby submit to the exclusive jurisdiction to the Delhi Courts of Laws.
