## OFFICE MEMORANDUM

Sub: - Policy granting one-time window to allottee Government Companies to surrender non-operational coal mines without penalty.

......

The undersigned is directed to state that the policy for granting one-time window to Government Companies to surrender non-operational coal mines without penalty has been approved on 07.04.2022.

- 2. Under the said policy, Government Companies or corporations, which have been allotted coal mines under the CMSP Act or the MMDR Act through allotment route, may surrender its non-operational coal block/ mine i.e., where mine opening permission could not be obtained by the allottee. Though reasons for surrender are not required but it is desirable that technical/mining related issues, if any, due to which the mine could not be operationalized be provided.
- 3. Upon acceptance of request for surrender, the performance security (bank guarantee) shall be returned to the allottee. Pending show cause notices, issued for delays, would be considered withdrawn. However, wherein order for appropriation has been issued such appropriation order shall not be waived off and the corresponding amount of performance security shall be forfeited. Other payments already made by the allottee, such as upfront amount, compensation paid to prior allottee, etc. shall not be returned.
- 4. Request for surrender must accompany copies of consents/clearances obtained by the allottee and copies of land documents, if any. Any other document or information sought by the Nominated Authority shall be provided by the allottee within the time specified by the Nominated Authority.
- 5. Accordingly, the allottee Government Companies or corporations may submit their request to surrender as per the Annexure-A to the Nominated Authority within **three months' time** from the date of issue of this OM. Any request received after the said time shall not be considered. Cases of surrender/ termination of allocation orders of coal mines which have been disposed of by Nominated Authority/Ministry of Coal shall not be re-opened under this policy. Allottee Government Companies or Corporations whose request for surrender of non-operation coal mines/blocks is pending with the Nominated Authority as on date of publishing of this OM need to apply afresh for benefit under the instant policy.
- 6. Allottees must submit the request for surrender in writing by the authorized signatory to O/o Nominated Authority, Room No. 120-F, Shastri Bhawan, New Delhi-110001. The request must accompany board resolution expressly resolving for surrendering of coal mine and designating an authorized signatory for making the



said request. The request for surrender along with the accompanying documents must be received at the address specified within three months from the date of this OM.
