I am directed to refer to this Ministry's letter No. 43021/2/2017-LA&IR dated 28.09.2020, wherein the approval of the competent authority was conveyed to the continuance of the Part Time Tribunals at Godda, Dhenkanal, Talcher, Ranchi, Bilaspur, Singrauli and Mirzapur upto 30.09.2022, under the provision of section 14(2) of the Coal Bearing Areas (Acquisition & Development) Act, 1957 for the purpose of determining the amount of compensation in case of disputes arising in respect of Coal Bearing Areas in the concerned states on the existing term and condition.

2. As the extension accorded to the PTTs was going to expire on 30.09.2022, all the PTTs were requested vide this Ministry's letter of even number dated 8th August, 2022 to furnish information/details of cases pending, filed and disposed of, in each PTT during last three years.

- Based on the information received from the PTTs, the matter has been 3. examined in the Ministry of Coal and to inform you that the competent authority in Ministry of Coal has approved the extension of the Six Part Time Tribunals at Godda, Ranchi, Bilaspur, Singrauli, Mirzapur and Jharsuguda for a period of two years from 01.10.2022 to 30.09.2024 and for rest 02 PTTs (Dhenkanal & Talcher) for a limited period beyond 30-09-2022 i.e. until the Special Tribunal (Full Time) at Talcher comes into existence whichever is earlier, by merging these two PTTs.
