Sir,

I am directed to inform that as per Ministry's letter No. 20012/6/2020-CMPF dated 20th April, 2022 it was directed to take the following measures with regard to the shortage of Group 'A' Officers:-

- (a) Take steps to fill up the vacant posts of 10 Regional Commissioner-II (PB-3 with GP 6600/-) and 10 Assistant Commissioners (PB-3 with GP 5400/-) on deputation basis from various Government Departments.
- (b) Commissioner, CMPFO is also advised to search for suitable officers in Coal PSUs who could be taken on loan basis to meet the crisis, and send specific proposal in this regard to this Ministry for approval.
- 2. In compliance with the MoC's letter dated 20th April, 2022, the vacancies were published in Employment News two times for filling up of 10 posts of Regional Commissioner-II in Level-11 of Pay Matrix and 10 posts of Assistant Commissioner in Level-10 of Pay Matrix on deputation basis. Only 02 Officers have joined in the post of Regional Commissioner-II and one offer of appointment has now been issued in the post of Regional Commissioner-II after obtaining the approval of Ministry. In so far as the post of Assistant Commissioner is concerned, total 05 officers have joined in the post of Assistant Commissioner in CMPFO.
- 3. Even after the efforts made by this Office, 07 posts of Regional Commissioner-II and 05 posts of Assistant Commissioner are yet to be filled up by deputation. In order to cope up with the acute shortage of Group 'A' Officers in CMPFO, an advertisement for filling up of 07 posts of Regional Commissioner in Level-11 of Pay Matrix and 05 posts of Assistant Commissioner in Level-10 of Pay Matrix on deputation basis has been published in the Official website of CMPFO vide Circular No. CMPFO/5/Adm/HQ/AC & RC-II/Deputation/2023/123 dated 24th May, 2023 (copy enclosed for perusal).

4. A Short-Circular No. CMPFO/5/Adm/AC & RC-II/Deputation/2023/125 dated 24th May, 2023 inviting application for filling up 07 posts of Regional Commissioner-II in Level-11 of Pay Matrix and 05 posts Assistant Commissioner in Level-10 of Pay Matrix is enclosed herewith for publication of the same through the DoP&T Portal to attract more eligible candidates.
