- 5. It is clarified that in case a mining lease has been executed in favour of a third party, subsequent to such allocation of Schedule I coal mines, then, the third party shall be deemed to be the prior allottee as per Section 3 (1) (n) of the Coal Mines (Special Provisions) Act 2015.
- 6. Claims lodged against earlier advertisements in respect of Schedule I coal mines are also required to be lodged afresh.
- 7. Claimants are required to specify the following category (ies) against their claims:
  - a. Secured Creditors, Central Government/ Government of India, any of the department or ministries of the Government of India: for all revenues, taxes, cess, additional levy and rates.
