O.S.R. 987.—In exercise of the powers conferred by the provise to Article 309 of the Constitution and in supersession of the Coal Controller's Organisation (Class I Posts) (Class I Posts)

- 1 Short title and commencement.—(1) These rules may be called the Coal Controller's Organization (Group 'A' Posts) Recruitment Rules, 1986.
- (2) They shall come into force on the date of their publication in the Official Gazzuc.
- 2. Number of posts, classification and scale of pay.—The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualification etc.— The medited of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as speci-

fied in columns 5 to 14 of the said schedule.

- 4. Disqualification.-No person,-
 - (a) who has entered into or cont-acted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if 'satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so daing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of opinion that it is necessary or expedient so to, do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or calegory of persons.
- 6. Saving.—Nothing in these rules shall effect reservations, relexation of age limit and other concessions required to be named of the Scheduled Castes, the Scheduled Tribes, extervicement and other arectal enlegation of persons in accordance with the orders issued by the Central Government from time to time in this regard.
