- iv. <u>Local Authority(ies)</u>: for all revenues, taxes, cess, additional levy, and rates due from the prior allottee on 31.03.2015 & 24.09.2014 and becoming due and payable immediately before that date.
- 2. All the above-mentioned claims, along with supporting documents, must be submitted in a sealed envelope, clearly marked as "Submission of Claims for [insert name of the coal mine]," before 12:00 noon on September 04, 2023, to the O/o Nominated Authority, Room No. 120-F, 1st Floor, ShastriBhawan, New Delhi-110001.
- 3. Additionally, scanned copies of the claims should be sent to the email address: nomauthority.moc@nic.in before 5:00 P.M on September 04, 2023. The email subject should be "Submission of Claims for [insert name of the Coal Mine]."
- 4. It may, please be noted that claims received after 5:00 P.M on 04.09.2023 will not be considered.
- 5. It is important to clarify that if a mining lease has been granted to a third party after the allocation of Schedule I coal mines, the third party shall be considered the prior allottee as per Section 3(1)(n) of the Coal Mines (Special Provisions) Act 2015.
- 6. All claimants who had previously lodged claims against advertisements for Schedule I coal mines are required to submit their claims afresh.
- 7. Claimants are requested to specify the applicable category(ies) for their claims:
  - i. Secured Creditors, Central Government/Government of India, any departments, or ministries of the Government of India: for all revenues, taxes, cess, additional levy, and rates.

- ii. State Government(s), any departments, or ministries of the State Government(s): for all revenues, taxes, cess, additional levy, and rates.
- iii. Local Authority(ies): for all revenues, taxes, cess, additional levy, and rates due.
- iv. Any other category.
- 8. All claims must be accompanied by an affidavit in the enclosed format (Annexure II), duly sworn in by the claimant.
