FINAL COMPENSATION ORDER

Subject: The Coal Mines (Special Provision) Act, 2015, and the Hon'ble High Court of Delhi judgment dated March 09, 2017, which pertains to the valuation of compensation for Cost of Geological Reports (GR) and Cost of Consents (CC) payable to prior allottees, M/s Bhushan Power and Steel Limited (formerly known as M/s Bhushan Limited) and M/s Shri Mahavir Ferro Alloys Pvt Limited, for Bijahan coal mine.

In accordance with the provisional compensation order dated October 16, 2023, a meeting was convened on October 20, 2023, at 3:30 PM, to present the comments or objections from both the prior allottees, M/s Bhushan Power and Steel Limited (formerly known as M/s Bhushan Limited) and M/s Shri Mahavir Ferro Alloys Pvt Limited (SMFAPL), as well as the successful allottee, M/s Mahanadi Mines and Minerals Private Limited (MMMPL), regarding the determination made by the Nominated Authority.

- 2. During the meeting, M/s Bhushan Power and Steel Limited (BPSL) and M/s Mahanadi Mines and Minerals Private Limited (MMMPL) were present to discuss the provisional compensation determination. However, one of the prior allottees, M/s Shri Mahavir Ferro Alloys Pvt Limited, was absent during the provisional compensation determination.
- 3. Subsequently, M/s BPSL (prior allottee) and M/s MMMPL (successful allottee) accepted the provisional compensation determination dated October 16, 2023, pertaining to the Cost of Geological Reports (GR) and the Cost of Consents (CC) for the Bijahan coal mine.
- 4. Thereafter, M/s BPSL requested that the compensation be released solely to them, as M/s MFAPL (associates) had no role in the development of the block or coal production, except for sharing the coal produced. M/s BPSL stated that a bipartite agreement was executed between M/s BPSL (the leading company) and M/s SMFAPL (the associate company) on January 30, 2007. The agreement mutually agreed between both parties has been furnished by M/s. BPSL (copy enclosed) wherein it is mentioned that the mining lease would be executed in the name of M/s BPSL, the leading company, and all mining operations and investments would be undertaken by the leading company. Therefore, all the compensation for costs of GR and CC shall be released to M/s. Bhushan Power & Steel Ltd.
- 5. In view of the above, compensation towards Cost of Geological Reports (GR) and Cost of Consents (CC) for Bijahan coal mine has been finalized and is as detailed in Table 'A' below:
